



## Clara Wepprecht

May 23, 1907 - August 5, 2005

Visitation for Clara L. Wepprecht, 98, of Kankakee, will be from 4-8 p.m. Tuesday at Clancy-Gernon-Hertz Funeral Home, West Kankakee. A funeral Mass will be celebrated at 10 a.m. Wednesday at St. Patrick's Catholic Church in Kankakee. Burial will be in Mount Calvary Cemetery. Mrs. Wepprecht died Friday (Aug. 5, 2005) at Miller Center. She was born May 23, 1907 in Kankakee, the daughter of Benjamin and Winifred Schneider Gerard. Her first husband, Howard Folwell, whom she married Nov. 2, 1929 in Fairbury, died Oct. 29, 1954. She then married Omar Wepprecht Feb. 12, 1957. He died Sept. 23, 1998. She was a senior loan officer and assistant secretary for Kankakee Federal Savings & Loan, retiring after 22 years. She also worked for F.O. Savoie Wholesale Grocers for 25 years. She was a graduate of Kankakee High School, a member of St. Patrick's Catholic Church, Delphi, and a charter member of the Kankakee County Legal Secretaries. Surviving are one son and daughter-in-law, Raymond and Joan Folwell of Pullman, Wash.; two stepsons and stepdaughters-in-law, Ronald and Elaine Wepprecht of Mackinaw, John and Dolores Wepprecht of Essex; two stepdaughters and one stepson-in-law, Sandra and Dan Ryan of Union Hill, Joyce Raab of Bradley; two grandchildren, Matthew Folwell of Spokane, Wash, Annette Folwell of Moscow, Idaho; 11 stepgrandchildren; several stepgreat-grandchildren; and several nieces and nephews, including Elaine (Joseph) Peppin of Bradley, whose loving care Clara especially appreciated.
