Mr. Bradecich was a retired employee of Premier Data Solutions and a former employee of First Trust Bank (1977-1988). He did voice-over work in the recording industry. He was born Dec. 8, 1947, in Kankakee, the son of John J. and Florence Mulcahy Bradecich. His wife, the former Susan Grumish, whom he married Dec. 6, 1968 at St. Martin of Tours Catholic Church, Kankakee, died April 5, 1991. He was a 1966 graduate of Bishop McNamara High School. He served in the U.S. Army from 1968-1970 in Germany. He was a member of the Elks Country Club and the Knights of Columbus. He was a former member of the Elks Lodge. He enjoyed golfing and spending time with friends. Surviving are two sons and daughters-in-law, Dr. Jason and Dessislava Bradecich of Virginia Beach, Va., Michael and Abigail Bradecich of Chicago; his mother of Bourbonnais; best friend, Ginny Osenga; and several brothers-in-law and sisters-in-law, including Dr. John Grumish of Bourbonnais.
