



J. Scott Swaim

November 3, 1946 - February 22, 2009

The Honorable J. Scott Swaim, 62, of Bourbonnais, died Sunday (Feb. 22, 2009). Visitation will be from 4 p.m. to 8 p.m. Wednesday at the Clancy-Gernon Funeral Home in Bourbonnais, and from 10 a.m. Thursday at the College Church of the Nazarene, until the 11 a.m. services, with military rites at the church. Cremation rites will be accorded. In lieu of flowers, memorials may be made to Hospice of Kankakee Valley. Mr. Swaim was a Kankakee County Circuit Court judge and formerly a private practice attorney with his father. He was born Nov. 3, 1946, in Rensselaer, Ind., the son of George T. and Mary J. Sellers Swaim. He was a 1964 graduate of Kankakee High School, a graduate of the College of Wooster, Wooster, Ohio, and a graduate of Tulane University Law School in New Orleans. He was a retired lieutenant colonel with the U.S. Marine Corps Reserves. He was a member of the College Church of the Nazarene, the YMCA, The Shriners, Masons, and the Kankakee Country Club. He had also taught at Kankakee Community College. Surviving are one son, J. Swaim of Kankakee; one grandson, Jack Swaim; his father and stepmother, George T. and Alice Swaim of Manteno; one sister, Sheryl Swaim and August Spivey of Newport Beach, Calif.; two brothers and one sister-in-law, G. Tupper and Yhvonne Swaim of Indiana, F. Michael Swaim of Kankakee; and special friend, Michelle Arseneau. His mother is deceased.



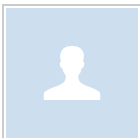
