LaVerne E. Sutter, 85, of Union Hill, died Saturday (Feb. 23, 2013) at Harvest View in Herscher. Visitation will be from 4 p.m. to 8 p.m. Wednesday at the Clancy-Gernon-Hertz Funeral Home, west Kankakee, where funeral services will be held at 11 a.m. Thursday. Pastor John Kiefer will officiate.
