Visitation for Robert "Bob" F. Wingerter, 79, of Martinton, will be from 4-8 p.m. Friday, with an 8 p.m. wake service, at Clancy-Gernon-Houk Funeral Home, St. Anne. A funeral Mass will be celebrated at 10 a.m. Saturday at St. Martin's Catholic Church, Martinton. Rev. Robert Coleman will officiate. Burial will be in Mt. Olivet Cemetery, Martinton. Memorials may be made to Hospice of Iroquois County. He died Monday (Sept. 12, 2005) at his home. Mr. Wingerter was a chemical worker at Henkel Corporation, retiring after 44 years of service. He was born July 9, 1926, in Wichert, the son of Frank and Bessie Sutton Wingerter. He served in the U.S. Army during World War II (1946-48). He was a member of St. Martin's Catholic Church, Martinton, where he was a eucharistic minister, usher and church maintenance worker. He was a member of the Chebanse VFW and the Henkel 25 Year Club. He enjoyed his church, gardening and draft horses.
